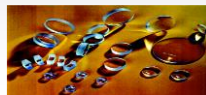

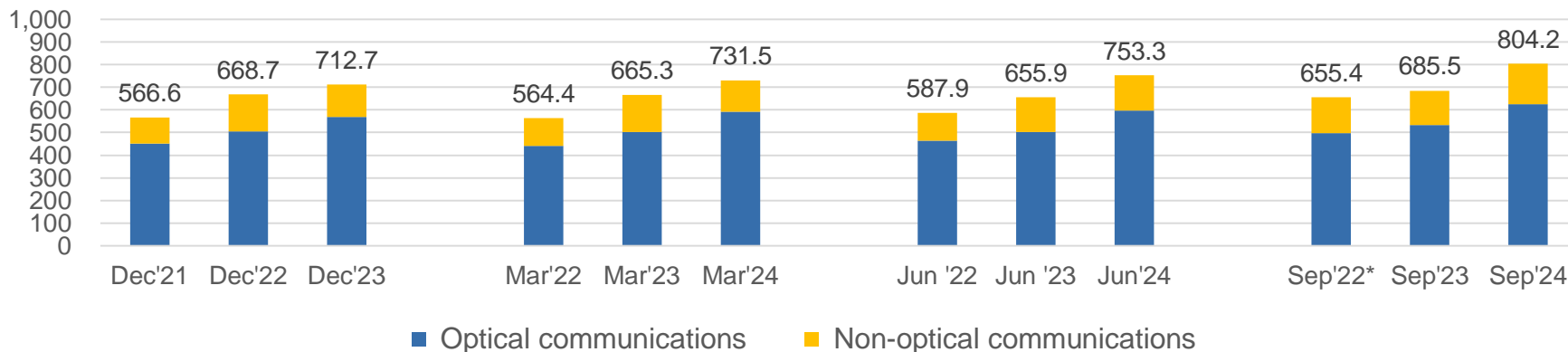

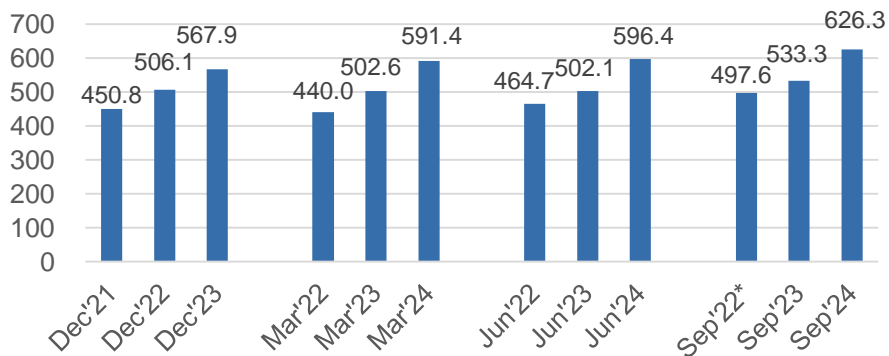

Strong Revenue Trends

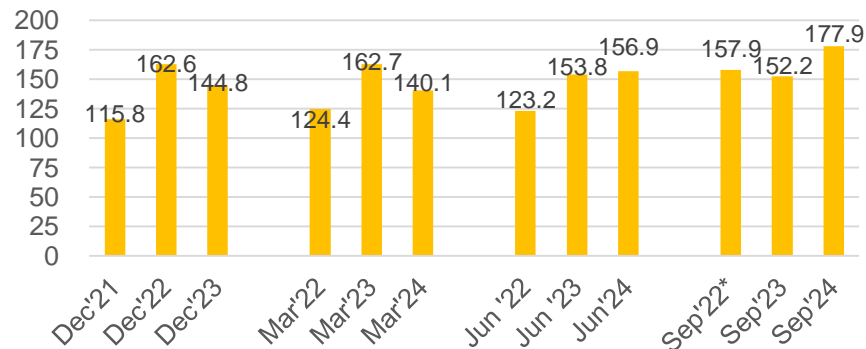
QUARTERLY CONSOLIDATED REVENUE (\$M)



OPTICAL COMMUNICATIONS REVENUE (\$M)



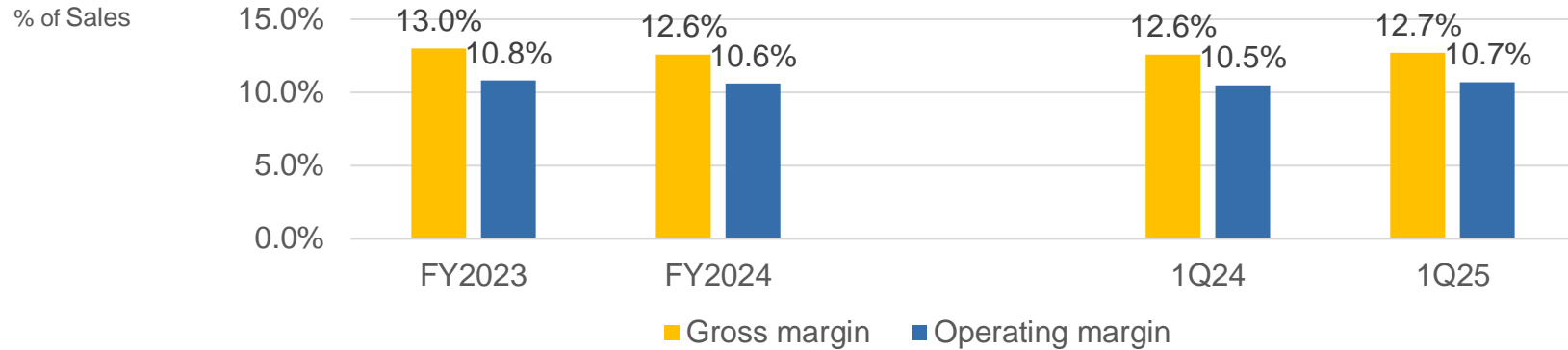
NON-OPTICAL COMMUNICATIONS REVENUE (\$M)



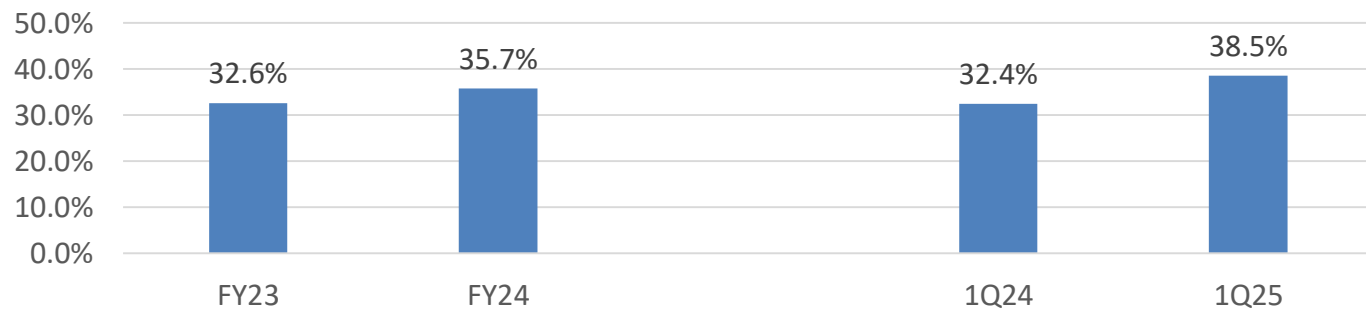
